1		①所有打包带颜色为黑色; ②所有打包带完整, 无断裂; ③打包带在缠绕膜内部, 而非外部; ④每一个面打包带数量为单层, 2条; ⑤打包带从栈板底部穿入捆扎, 而非木箱和栈板之间; ⑥打包带紧绷, 无松垮;	1.All strapping bands should be black in color. 2.All strapping bands must be intact, with no breakage. 3.The strapping bands should be inside the stretch film, not outside. 4.The number of strapping bands on each side should be a single layer, with 2 bands. 5.The strapping bands should pass through the bottom of the pallet for bundling, not between the wooden box and the pallet. 6.The strapping bands should be tight, with no slack.

3		①木箱侧面的防倾倒标签, 箭头内圆圈为金属原银白色, 未变红;	The anti-tip label on the side of the wooden box, with the arrow's inner circle in metallic silver, should not have turned red.	
4		①木箱钢边舌扣全部折弯压紧;	1.All steel edge tongue clips of the wooden box should be bent and pressed tightly.	
5		①木箱标签纸完好无破损;	1.The label paper on the wooden box should be intact and free of damage.	
6		①机柜与栈板固定的螺丝, 在栈板底部螺丝和垫片完整无缺, 共4处;	1.The screws fixing the cabinet to the pallet should be complete, with the screws and washers intact at the bottom of the pallet, a total of 4 locations.	

7		<p>机柜与木箱固定螺丝检验：</p> <p>①机柜与栈板固定的螺丝，在栈板底部螺丝和垫片完整无缺，共4处（左图）；</p> <p>②木栈板钢带上的刻度线和木箱侧板钢带上的刻度线对齐（右图）；</p> <p>注：老的包装无此刻度线、部分包装刻度线在底部螺丝上，会存在新旧包装混搭的情况</p>	<p>Align the scale line on the wooden pallet with the scale line on the screw (note that the old packaging does not have this scale line, so there may be a mix of old and new packaging).</p>	
8		<p>防倾倒标签检验（机器）：</p> <p>①木箱面板上防倾倒标签如发生破坏，可以进一步拆掉木箱确认机柜内的防倾倒标签有无变色，共两处；</p>	<p>Anti-dumping label inspection (machine):</p> <p>① If the anti-dumping label on the wooden box panel is damaged, you can further remove the wooden box to confirm whether the anti-dumping label in the cabinet has changed color, a total of two places (be introduced after May 2025)</p>
